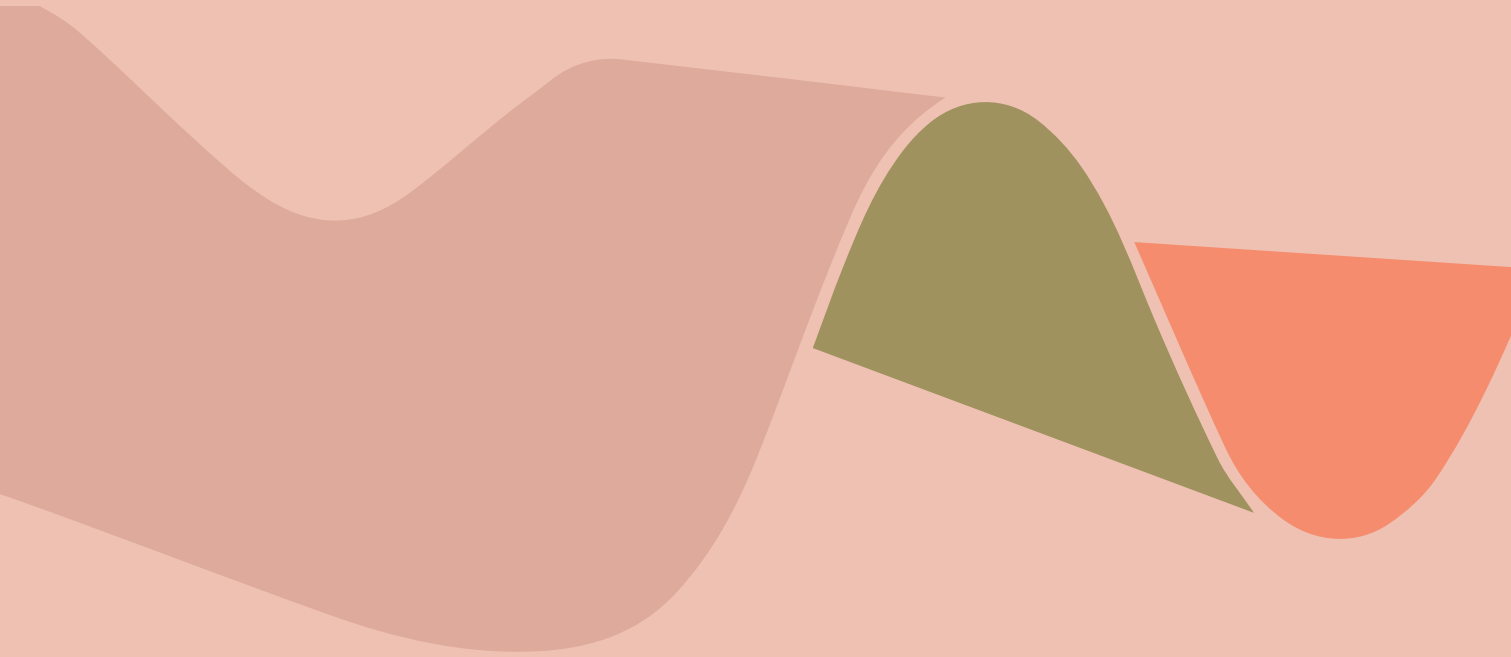

Product Limited Warranty



## 5 Year Limited Warranty Cubeflex Re-engineered Veneer



1. This Warranty only covers Cubeflex Re-engineered Veneer range of products (to be known as the product).
2. Subject to conditions and limitation set out in this warranty below, Getz Bros & Co. (Singapore) Pte Ltd warrants the original purchaser of the products for interior residential or interior commercial use and will at its option repair or replace any of its product without charge if it is defective directly as a result of its manufacture or supply on the materials used in its first five years after initial purchase (proof of purchase will be required). Subject to paragraph 7, this obligation terminates at the expiration of five years from the date of purchase of the product concerned from Getz Bros & Co. (Singapore) Pte Ltd.
3. This warranty does not cover any defect caused by:
  - I. Any act of god, any natural occurrence, or any other act or circumstances beyond Getz Bros & Co. (Singapore) Pte Ltd control; or
  - II. Failure to follow any procedures recommended by Getz Bros & Co. (Singapore) Pte Ltd, at the time of fabrication, sale and/or installation of the product.
  - III. Physical abuse, misuse, accidents, exposure to excessive heat, exposure to excessive moisture, the use of solvents or inappropriate cleaning product/materials, improper maintenance, normal 'wear and tear', scratches, scuffs, burns, stains, wipe marks on darker color surfaces, exposure to chemical products; or
  - IV. General fading and discoloration or damage due to direct and indirect light (exposure to sunlight should be avoided); or
  - V. The product being used in applications that are not recommended by Getz Bros & Co. (Singapore) Pte Ltd in the product literature published; or
  - VI. Where the defect has been caused by faulty workmanship by any person other than Getz Bros & Co. (Singapore) Pte Ltd; or
  - VII. Variation in color, pattern, shade of material against the sample material, displays and/or printed illustrations.
  - VIII. Where the defect is trivial or insubstantial; or
  - IX. Where as at the date of notification of the defect to Getz Bros & Co. (Singapore) Pte Ltd, the type or color of the alleged defective product no longer forms part of Cubeflex Re-engineered Veneer standard stock range and the person complaining of the defect does not agree to the supply of a replacement which as close a type or color match as is possible from Getz Bros & Co. (Singapore) Pte Ltd then prevailing stock range; or
  - X. Anything that has been disclosed as a feature or limitation of the product in any literature published by Getz Bros & Co. (Singapore) Pte Ltd; or
  - XI. Outdoor application.
4. This warranty applies only to Cubeflex Getz Bros & Co. (Singapore) Pte Ltd product:
  - I. Purchased from Cubeflex from Getz Bros & Co. (Singapore) Pte Ltd after January 2019 for interior residential or interior commercial use in Singapore.
  - II. That has remained installed at the location at which it was first installed after its sale by Getz Bros & Co. (Singapore) Pte Ltd
  - III. Which has been installed, maintained, used and protected in the manner recommended by Getz Bros & Co. (Singapore) Pte Ltd, as at the relevant time of such installation, maintenance, use or protection, in its literature published from time to time concerning the product, a copy of which may be obtained online by visiting [www.cubeflex.co](http://www.cubeflex.co).
  - IV. Where Getz Bros & Co. (Singapore) Pte Ltd has been notified of the defect within seven days of the first person to become aware of it.
5. This warranty will cover reasonable labor charges which are necessary for the repair or replacement of the product covered by this warranty.
6. A replacement product may not be reasonably available from Getz Bros & Co. (Singapore) Pte Ltd in the same shape, type or color as the original product covered by this warranty. If a replacement product of the same shape, type or color is not reasonably available, Getz Bros & Co. (Singapore) Pte Ltd reserves the right to provide a replacement product of as close a shape, type and color match as is reasonably possible from Getz Bros & Co. (Singapore) Pte Ltd's then prevailing product range in satisfaction of its obligations under this warranty.
7. Except as expressly provided in paragraphs 2 and 8, all terms, conditions, warranties, undertakings, inducements and representations, whether express or implied, statutory or otherwise relating in any way to the product are excluded. Without limiting the generality of the preceding sentence, Getz Bros & Co. (Singapore) Pte Ltd will not be under any other liability in respect of any loss or damage (including consequential loss or damage) however caused (whether by negligence or otherwise) which may be suffered or incurred or which may arise directly or indirectly in respect of the product.
8. Where any legislation implies any term, condition or warranty into the contract sale between Getz Bros & Co. (Singapore) Pte Ltd and a person, or Getz Bros & Co. (Singapore) Pte Ltd relationship with a person, which has acquired its product, or otherwise gives that person a particular remedy against Getz Bros & Co. (Singapore) Pte Ltd, and that legislation or any legislation voids or prohibits any provision excluding, or modifying the application of, or exercise of, any liability under such term, condition, warranty or remedy, then that term, condition, warranty or remedy shall be deemed to be included in or, as the case may be, apply to that contract or relationship. However, Getz Bros & Co. (Singapore) Pte Ltd's liability for any breach of such term, condition or warranty or such remedy, shall be limited, at Getz Bros & Co. (Singapore) Pte Ltd option, in any one or more of the ways permitted by that legislation including, where so permitted:
  - I. If the breach to a product from Cubeflex by Getz Bros & Co. (Singapore) Pte Ltd:
    - I. The replacement of the product or the supply of the equivalent product;
    - II. The repair of the product;
    - III. The payment of the cost of replacing the product or acquiring equivalent product; or
    - IV. The payment of the cost of having the product repaired; and
  - II. If the breach related to services:
    - I. The supplying of the services again; or
    - II. The payment of the cost of having the services supplied again.
9. Please note that the law may confer on persons rights arising out of the supply of Cubeflex product. This warranty should not therefore be read as an exhaustive statement of the rights of the original purchaser or any other person. Nothing in this warranty shall affect any rights a consumer may have under current consumer acts in Singapore.
10. This warranty does not cover any other product used or installed in connection with the product.
11. This warranty is not transferable or assignable.
